Caton Flats Affordable Housing Applications

Caton Flats is a mixed-use development located in the Flatbush section of Brooklyn at 800 Flatbush Avenue (NW corner of Caton and Flatbush Avenues.) The site was developed as the new home for the Flatbush Caton Market; the Flatbush headquarters for the Caribbean American Chamber of Commerce and Industry (CACCI); a new business incubator; and 100% affordable housing. All of the 254 apartments will be affordable, with rent- and income-restrictions targeting them for families and individuals who are between 40% to 165% of AMI. To learn more, visit catonflats.com.

NYC Streets Master Plan

NYC Department of Transportation (DOT) is developing the <u>NYC Streets Plan</u>, a five-year transportation plan to improve the safety, accessibility, and quality of the City's streets for all. The plan will involve an analysis of the current state of New York City's streets and seeks to respond to the City's many neighborhoods and local needs. The plan is being developed in response to <u>Local Law 195</u> enacted in December 2019, which directs NYC DOT to issue and implement a transportation master plan every five years. The final NYC Streets Plan will be released in December 2021.

Community members are invited to participate in the process. Public input will help DOT prioritize transportation projects and programs throughout New York City. Residents can participate and share ideas at public workshops and via an online public survey.

Public Workshops: DOT is hosting ten virtual public workshops between July 7 - July 29, 2021. **The workshop for CB 14 is on Thursday, July 8th.** A second round of workshops will be held in the fall. Each workshop will focus on different neighborhoods and areas of the city to allow you to provide insights on the areas you know best. Fiscal Year 2023 Community Budget Recommendations

Each year, in accordance with the New York City Charter, all 59 NYC Community Boards are required to submit recommendations for NYC's capital and expense budgets for the upcoming fiscal year. Community members are invited to participate in the budget process by suggesting a new city service or capital project. A capital project generally has a value of \$35,000 and a "useful life" of at least five years. Requests for ongoing programs and regular city services such as street signs, building inspections, parks maintenance, road repair or tree pruning, for example, should be directed to the Community Board office as a routine service delivery request.

NYC Zoning Text Amendments

NYC City Planning has proposed several new <u>zoning text amendments</u> to help the City thrive while recovering from the long-term impacts of the Covid-19 pandemic. <u>Elevate Transit Zoning for Accessibility</u>: Zoning for Accessibility (ZFA) seeks to make our transit system more accessible and better coordinated with the streets and buildings around it. Through ZFA, developers would work with the MTA to set aside space where needed for station elevators. It would expand incentives for developers to build elevators and related station upgrades in new, high-density buildings. <u>Learn more about</u> Elevate Transit: Zoning for Accessibility.

<u>Health and Fitness Text Amendment</u>: Gyms, martial arts studios, licensed massage therapy, and many other health-related businesses require special permits from the Board of Standards and Appeals to open in most parts of New York City. The Department of City Planning is proposing new rules to ease these restrictions, cutting red tape for small businesses and providing valuable health amenities to all New York City communities. <u>Learn more about the Health and Fitness Text Amendment</u>.

<u>Citywide Hotel Text Amendment</u>: The Citywide Hotel Special Permit aims to create a consistent approach to hotel development citywide. The proposed zoning change would require City Planning Commission approval for new and enlarged hotels and motels, tourist cabins and boatels in commercial, mixed-use and paired M1/R districts. FRESH Food Stores Update: The Department of City Planning is proposing to update and expand the FRESH food stores program, which supports convenient, accessible grocery stores in underserved neighborhoods. The update would bring the FRESH program to more communities, among other changes to ensure FRESH stores are evenly distributed and financially viable. Learn more about the FRESH Food Stores Update.

A cooling center is a facility, such as a senior center or community center, where people may go to enjoy air-conditioned comfort during a heat emergency.
