Join CB14 for a public hearing about NYC Capital & Expense Budgets for Fiscal Year 2023 at 6:45 PM, followed by the regular monthly board meeting of Brooklyn Community Board 14 at 7 PM.

Community members are encouraged to participate in the budget process by submitting [Community Budget Recommendations](#) for new city services or capital projects before the September 13th public hearing. A capital project generally has a value of \$35,000+ and a “useful life” of at least five years. Requests for ongoing programs and regular city services such as street signs, building inspections, parks maintenance, road repair or tree pruning, for example, should be directed to the Community Board office as a routine service delivery request. ## **Covid-19 Public Meeting Guidance**

As per NYS Executive Order 210, until further notice, agencies must adhere to the following guidance for public meetings subject to Open Meeting Law:

### **Face Coverings and Physical Distancing**

- Agencies must require all meeting attendees (City employees, visitors, and members of the public) over the age of two who are medically able to tolerate a face covering to wear a face covering at all times, regardless of vaccination status.
- Agencies must ensure all meeting attendees remain 6 feet apart at all times, regardless of vaccination status.

**Please do not attend public meetings if:**

- You have experienced any symptoms of COVID-19 within the past 10 days (a fever of 100.0 degrees Fahrenheit or greater, a new cough, new loss of taste or smell, or shortness of breath).
- You have tested positive for COVID-19 within the past 10 days.
- You have been in close contact (within 6 feet for at least 10 minutes over a 24-hour period) with anyone while they had COVID-19 within the past 10 days and are required to quarantine under existing CDC guidance (you have not had COVID-19 within the past 3 months, and you are not fully vaccinated).
